MUSIC INSTRUMENTAL PROGRAM

Mandurah Catholic College offers a comprehensive range of music tuition. Students enrolled in the Music Instrumental Program receive lessons from a suitably experienced music tutor provided as part of the co-curricular program at the College.

Tuition is available in the following instruments:

- Woodwind (Flute, Clarinet, Saxophone)
- Brass (Trumpet, Trombone, French Horn, Euphonium, Tuba)
- String (Violin, Contemporary/Electric Guitar, Guitar, Bass Guitar, Cello)
- Percussion (Drum Kit/Percussion, Piano)
- Voice

Students receive one (non-refundable) 30-minute lesson per week. Lessons will appear on the students SEQTA timetable which can be viewed by parents, students, and teachers.

PAYMENT OF ACCOUNTS

You are required to return your Payment Option Advice Form to the Finance Officer no later than 28 March, 2024. This form is sent to you with your annual invoice. All payments are to be finalised by 30 November, 2024. The College accepts Credit Card, Direct Debit, BPAY and Cheque. The College offers the following payment options:

OPTION 1	Annual Payment	Full year's fees paid in full by 31 March, 2024
OPTION 2	10 monthly, 20 fortnightly or 40 weekly	Fees paid in equal instalments from February - November
OPTION 3	Variations of these options, such as tax refund, bonuses, etc	Requires discussion with the Finance Officer Must be discussed by 28 March, 2024

****All College fees are reviewed annually. The College encourages paying fees upfront OR continuous fortnightly deductions as the preferred option for payment.***

CUSTODY, COURT/CONSENT ORDERS AND SPLIT FAMILY ARRANGEMENTS

Tuition accounts at Mandurah Catholic College are not 'split' (i.e. invoiced to parents separately). The signatories to the enrolment agreement are liable jointly and severally to pay for all fees and charges incurred in respect of that student, regardless of:

- (a) any pre-arranged or subsequent private agreement to share or apportion payment responsibility
- (b) any Court Order or statutory direction that may apply to any signatory
- (c) any separate or individual invoicing of any amount

This joint and several liability includes all costs that may be incurred by the School in the recovery of fees and charges including legal action, if necessary.

TUITION SWEEP

Families that pay their account in full by 31 March, 2024 will go into the draw to be eligible for a tuition fee credit for their eldest student in 2025, or a refund of their tuition fee if it is their student's last year in 2024. Winners will be contacted directly and announced on the College Facebook page.

AMENITIES FEE

This fee contributes to miscellaneous student related expenses. The balance of this expenditure is subsidised by the College.

ICT SERVICE FEE

This fee contributes to the costs of maintaining the technical support for all iPads and laptops.

FAMILY LEVIES

'Parents & Friends' Levy applies to all Primary and Secondary School families. This levy goes towards purchasing resources and equipment necessary for providing students with a quality education.

Building Levy is a compulsory payment and is **not tax deductible**. This levy applies to all Primary and Secondary School families and contributes towards the College, Maintenance and Capital Development. This is charged per family fee account and will not be split into other parent accounts. Parents can discuss sharing/adjusting this fee privately.

COMPULSORY ACTIVITIES, CAMPS, INCURSIONS, EXCURSIONS AND RETREATS

Correspondence including a Consent2Go notification will be sent detailing the activity. Please note there will be no refund/credits if your child does not attend any planned compulsory activity as these costs are pre-paid up to a year in advance.

INSURANCE

The College provides basic cover for every student through Catholic Church Insurance. This policy covers students 24/7/365 for accidents both in school and out while they are enrolled at the College.

TOURS

Tours are considered optional and are self-funded by attendees. They include Canberra Tour, Europe Tour, STEM USA Tour. Students will **not** be eligible to participate if school fees account is in arrears or no payment plan is in place.

HEALTH CARE CARD TUITION FEE CONCESSION

This is available to parents/guardians who hold a current means-tested Health Care Card or Pensioner/Veteran's Concession Card which bears the code "PPS". The child/children's name **must** be listed on the card. Applications for concession for Tuition Fees are only available from the Finance Officer. The concession card must be provided by **28 March, 2024** to be eligible for full discount. Late applications will be pro-rated. Concessions can only be applied during the validity period of the Health Care Card, ie, discounts will cease with Health Care Card expiry date.

SECONDARY ASSISTANCE SCHEME CONCESSION

This is offered by the Department of Education to parents/guardians holding a current means-tested Health Care Card or Pensioner/Veteran's Concession Card and includes a Clothing Allowance of \$115 (paid directly to the parent/guardian's bank account). Application for this concession has a Government cut-off date of **28 March, 2024**.

NOTICE OF WITHDRAWAL

Parents are required to give **one Terms notice in writing** if they choose to withdraw their child from the College during the course of the school year. If a student is withdrawn without notice during a term, fees for that term will also be charged, in addition to the term's notice.

Exiting families must settle any outstanding fees within four (4) weeks of exiting the College unless a payment arrangement has been negotiated and approved by the Business Manager.

LATE PAYMENT

In ensuring fairness and equity to families who pay fees in accordance with the College's Fee Procedure, the College rigorously follows up overdue accounts. Debt Collection Agencies or Solicitors may also be engaged and any costs incurred by the College in recovering fees will be charged to the account.

FINANCIAL DIFFICULTIES

The College accepts that from time to time, families may find themselves in difficult circumstances. Parents/guardians experiencing genuine financial hardship should contact the College at their earliest opportunity, to discuss alternative options for payment of tuition fees.
